*****If for any reason you change your mind about the puppy you picked for personal reasons you can place your deposit toward another. Only half the deposit will be applied. The other half will be forfeited. *** _____ Initial here****

It is not my responsibility to call you and find out why you missed picking up your puppy. It is your responsibility to call me and make further arrangements. _____ Initial here**

If for any reason this puppy has to be held past the date of pick-up there will be a 50.00 boarding fee per week that must be paid at time of pick up and we will not hold a puppy past two weeks. If for some reason it goes past two weeks the puppy will be placed back up for sale and the deposit will be forfeited as it is in the best interest for the puppy involved and that is of course the main objective here at Dachshunds by Tradewinds is the welfare of our puppies. _____ Initial here**
